# The BARN Horse Camp Release and Hold Harmless Agreement

I hereby waive, release and forever discharge all rights and claims for damages that may occur to me, a horse, or anyone under my supervision, arising out of or in any way connected with my participation to ride voluntarily at or on the homeowner's private property.
